#### Land Gazette Training –

As per By-law 17.1. Submission of Survey Plans and Descriptions – Council will be announcing early January, the commencement date when members are to start submitting survey plans into to the Association’s officially recognized land survey registry system (Land Gazette).

To ensure that membership have been provided adequate opportunity to be trained in the use of (Land Gazette); Information Brokerage Limited, in conjunction with the Association of Newfoundland Land Surveyors, will be setting up a one day training event for practising land surveyors in the province early in the new year. We are currently looking at 2 - 1 day sessions in St John's (min of 15 seats) and 1-1-day session in both Gander and Corner Brook (min of 10 seats).
